DEFINITIONS:

<u>Written Briefing</u>: Items that generally do not require a presentation or discussion by the staff or Council. On these items the staff is seeking direction from the Council or providing information in a written format.

<u>Verbal Briefing</u>: These items do not require written background information or are an update on items previously discussed by the Council.

<u>Regular Item</u>: These items generally require discussion between the Council and staff, boards, commissions, or consultants. These items are often accompanied by a formal presentation followed by discussion.

NOTICE: The City Council may recess from the open session and convene in a closed executive session if the discussion of any of the listed agenda items concerns one or more of the following matters:

- (1) Pending/contemplated litigation, settlement offer(s), and matters concerning privileged and unprivileged client information deemed confidential by Rule 1.05 of the Texas Disciplinary Rules of Professional Conduct. Sec. 551.071, Tex. Gov't Code.
- (2) The purchase, exchange, lease or value of real property, if the deliberation in an open meeting would have a detrimental effect on the position of the City in negotiations with a third person. Sec. 551.072, TEX. GOV'T CODE.
- (3) A contract for a prospective gift or donation to the City, if the deliberation in an open meeting would have a detrimental effect on the position of the City in negotiations with a third person. Sec. 551.073, TEX. GOV'T CODE.
- (4) Personnel matters involving the appointment, employment, evaluation, reassignment, duties, discipline or dismissal of a public officer or employee or to hear a complaint against an officer or employee. Sec. 551.074, Tex. Gov't Code.
- (5) The deployment, or specific occasions for implementation of security personnel or devices. Sec. 551.076, Tex. Gov't Code.
- (6) Discussions or deliberations regarding commercial or financial information that the City has received from a business prospect that the City seeks to have locate, stay, or expand in or near the territory of the City and with which the City is conducting economic development negotiations: or
- to deliberate the offer of a financial or other incentive to a business prospect of the sort described in this provision. Sec. 551.087, Tex. Gov't Code.
- (7) Discussions, deliberations, votes, or other final action on matters related to the City's competitive activity, including information that would, if disclosed, give advantage to competitors or prospective competitors and is reasonably related to one or more of the following categories of information:
 - generation unit specific and portfolio fixed and variable costs, including forecasts of those costs, capital improvement plans for generation units, and generation unit operating characteristics and outage scheduling;
 - bidding and pricing information for purchased power, generation and fuel, and Electric Reliability Council of Texas bids, prices, offers, and related services and strategies;
 - effective fuel and purchased power agreements and fuel transportation arrangements and contracts;
 - risk management information, contracts, and strategies, including fuel hedging and storage;
 - plans, studies, proposals, and analyses for system improvements, additions, or sales, other than transmission and distribution system improvements inside the service area for which the public power utility is the sole certificated retail provider; and
 - customer billing, contract, and usage information, electric power pricing information, system load characteristics, and electric power marketing analyses and strategies.

 - a. Construction Manager at Risk Bid No. 1972-11 Wallace and Lavon Pump Station Rehabilitations

This request is for construction manager at risk for the Wallace and Lavon Pump Station rehabilitations.

b. Water Meters for Warehouse Inventory

This request is for water meters for commercial and residential water distribution. The meters are standard warehouse inventory items to support Water Department operations.

This request is for all labor, equipment, and tools necessary to remove and replace existing underground cable in the ongoing Electric Distribution Maintenance Program.

d. Underground Line Locating Services

This request is for all labor and equipment necessary to provide distribution underground line locates.

3. A public hearing was previously conducted for the following zoning case. Council approved the request and instructed staff to bring forth the following ordinance for consideration.

Zoning File No. 11-34, Audio Zone

Consider an ordinance amending the zoning laws of the City of Garland by approving a Specific Use Permit for Automobile Repair, Minor on property zoned Shopping Center District on a 2.89-acre tract of land located at 1750 Northwest Highway, Suite 250B.

4. Consider by minute action authorizing the City Manager to execute a contract with RJN Group in an estimated amount of \$414,155.

Staff has negotiated a contract with RJN Group in an estimated amount of \$414,155 for the design of Section I of the West Pressure Plane Improvements 24" Pipeline. The limits of Section I are from the Wallace Pump Station (just west of Wallace Drive and Dairy Road) to the intersection of Fifth Street and Ridgedale Drive evaluating three possible routes previously determined in an initial alignment study.

5. Consider by minute action authorizing the City Manager to execute a contract with R-Delta Engineers, Inc. in an estimated amount of \$308.400.

Staff has negotiated a contract with R-Delta Engineers, Inc. in an estimated amount of \$308,400 for the design of Section II of the West Pressure Plane Improvements 24" Pipeline. The limits of Section II are from the intersection of Fifth Street and Ridgedale Drive to the intersection of Kingsley Road and Old Orchard Road.

6. Consider by minute action authorizing the City Manager to execute a contract with Freese and Nichols, Inc. in an estimated amount of \$279,360.

Staff has negotiated a contract with Freese and Nichols, Inc. in an estimated amount of \$279,360 for the design of Section III of the West Pressure Plane Improvements 24" Pipeline. The limits of Section III are from the intersection of Kingsley Road and Old Orchard Road to the intersection of Leon Road and McCree Road.

7. Consider a resolution authorizing the City Manager to execute Change Order No. 1 with Regenco.

At the January 3, 2012 Work Session, Council considered authorizing Change Order No. 1 in the amount of \$663,435 with Regenco for a declared emergency on unforeseen damage to the ROP Unit #2 Generator Field.

8. Consider a resolution appointing Elaine Simpson as the interim City Secretary.

The current City Secretary has announced her pending resignation from the City of Garland. At the January 3, 2012 Executive Session, Council considered the appointment of Elaine Simpson as the interim City Secretary until such time as Council appoints a City Secretary.

9. Consider by minute action authorizing the City Manager to execute a consulting agreement with Ray Schwertner.

At the January 3, 2012 Executive Session, Council discussed the reassignment of Ray Schwertner, Managing Director of Electric Utility, to a consulting basis. A consulting agreement has been prepared by the City Attorney.

ITEMS FOR INDIVIDUAL CONSIDERATION

Speaker Regulations:

10. Presentation of the 2012 Proposed Capital Improvement Program.

The City Manager will formally present the 2012 Proposed Capital Improvement Program for Council's review and deliberation.

11. Hold a public hearing on the following zoning case:

Consider the application of Onyx Builders, requesting approval of 1) a change of zoning from Planned Development (PD) District 05-55 for Single Family, Attached Uses (Townhouses) to a Planned Development (PD) District for Single Family Uses, 2) a Detail Plan for 63 single family residences, and 3) a waiver of Section 31.27 of the City of Garland Code of Ordinances regarding the requirement of alleys. The property is located north of the intersection of Roan Road and Rowlett Road. (File 11-31)

The proposal is for approval of 1) a change of zoning from a Planned Development for Single Family Attached Uses to a Planned Development for Single Family, 2) a Detail Plan for 63 single family residences, and 3) a waiver

regarding the requirement of alleys. At the October 24, 2011 meeting, the Plan Commission (by an 8 to 0 vote) recommended approval of the request.

12. Consider appointments to Boards and Commissions.

Board members are selected for two-year terms by the City Council in August. Terms are usually staggered whereby at least half of the membership has board experience. Board members are appointed based on qualifications.
