(4) Personnel matters involving the appointment, employment, evaluation, reassignment, duties, discipline or dismissal of a public officer or employee or to hear a complaint against an officer or employee. Sec. 551.074, TEX. GOV'T CODE.

(5) The deployment, or specific occasions for implementation of security personnel or devices. Sec. 551.076, TEX. GOV'T CODE.

(6) Discussions or deliberations regarding commercial or financial information that the City has received from a business prospect that the City seeks to have locate, stay, or expand in or near the territory of the City and with which the City is conducting economic development negotiations; or

to deliberate the offer of a financial or other incentive to a business prospect of the sort described in this provision. Sec. 551.087, TEX. GOV'T CODE.

(7) Discussions, deliberations, votes, or other final action on matters related to the City's competitive activity, including information that would, if disclosed, give advantage to competitors or prospective competitors and is reasonably related to one or more of the following categories of information:

- generation unit specific and portfolio fixed and variable costs, including forecasts of those costs, capital improvement plans for generation units, and generation unit operating characteristics and outage scheduling;
- bidding and pricing information for purchased power, generation and fuel, and Electric Reliability Council of Texas bids, prices, offers, and related services and strategies;
- effective fuel and purchased power agreements and fuel transportation arrangements and contracts;
- risk management information, contracts, and strategies, including fuel hedging and storage;
- plans, studies, proposals, and analyses for system improvements, additions, or sales, other than transmission and distribution system improvements inside the service area for which the public power utility is the sole certificated retail provider; and
- customer billing, contract, and usage information, electric power pricing information, system load characteristics, and electric power marketing analyses and strategies. Sec. 551.086; TEX. GOV'T CODE; Sec. 552.133, TEX. GOV'T CODE]

a. Assistance Request for Nonprofit Special Event

The City Council Policy on Special Event Policies and Guidelines (OPNS-29) states that requests from nonprofit organizations for donated services in excess of \$5,000 be brought to Council for consideration. The Noon Exchange Club of Garland has requested that Council consider waiving expenditures for City services required for their Labor Day parade and afternoon festivities in Central Park on Monday, September 3, in the amount of \$10,534.

b. Amend Tax Roll

As required by generally accepted accounting principles, Council annually amends the tax roll to reflect uncollected ad valorem taxes. Although the tax roll is reduced by this action, collection efforts continue unless the costs of these efforts exceed potential revenues. If Council concurs, this item will be scheduled for formal consideration at the September 4, 2012 Regular Meeting.

c. Amendment Agreement No. 3 to Red Light Automated Enforcement Service Agreement

The agreement between the City and its automated red light enforcement vendor (Xerox State and Local Solutions, Inc.) is in need of updating in order to formalize a number of operational changes that the parties have operated under for some time as well as provisions that are either no longer necessary or are in need of modification. This item is scheduled for formal consideration at the August 21, 2012 Regular Meeting.

CONSIDER ASSISTANCE REQUEST FOR NONPROFIT SPECIAL EVENT

ISSUE

The City Council Policy on Special Event Policies and Guidelines (OPNS-29) states that requests from nonprofit organizations for donated services in excess of \$5,000 be brought to the City Council for consideration. The Noon Exchange Club of Garland has requested Council to consider waiving expenditures for city services required for their Labor Day parade and afternoon festivities in Central Park on Monday, September 3, 2012.

OPTIONS

The City Council may: 1) approve the proposed recommendations for special events assistance, 2) deny or revise proposed funding levels, or 3) return the item to staff for further review and recommendations.

RECOMMENDATION

Staff recommends the City Council approve assistance for the Garland Labor Day Exchange Event by waiving fees and charges for City services in the amount of \$10,534.

BACKGROUND

By assisting various nonprofit organizations through the donation of City services for nonprofits' special events, the City promotes and celebrates the vitality and diversity of

the community. From parades and festivals to various multicultural events, the City of Garland is showcased through the efforts of these nonprofit organizations.

A spokesperson from the Garland Noon Exchange Club provided an event overview at the August 6 Work Session. The Garland Labor Day Exchange Event parade will follow the same route as previous years' Labor Day parades, ending in Central Park where afternoon activities will be provided. Proceeds from the parade are proposed to benefit the Garland Noon Exchange Club scholarship fund for local students and other youth programs.

CONSIDERATION

The 2011-12 annual operating budget has \$30,500 budgeted in the General Fund (non-departmental) to provide assistance in covering fees and charges for City services for special events held by nonprofit organizations. The proposed assistance is within the budgeted amount.

Policy Report

AMEND TAX ROLL

ISSUE

Annually, Council is asked to consider amending the tax roll to reflect uncollected ad valorem taxes, as required by generally accepted accounting principles. <u>Although the tax roll is reduced by this action, collection efforts continue unless the costs of these efforts exceed potential revenues.</u> Staff requests Council consideration to proceed with the annual tax roll amendment process.

OPTIONS

- 1. Consider an ordinance at the September 4, 2012 Regular Agenda Meeting to amend the City's tax roll by \$127,572.50.
- 2. Do not amend the City's tax roll and risk potentially receiving a qualified audit opinion.

RECOMMENDATION

Consider an ordinance on September 4, 2012 to amend the tax roll of the City for ad valorem tax amounts that have remained uncollected for a period of at least four years (two years for bankruptcy settlements).

COUNCIL GOAL

Financially Stable Government with Tax Base that Supports Community Needs

BACKGROUND

Under Article IX, Section 3 of the City Charter, the City Council has the authority to amend the tax roll for uncollected ad valorem taxes. Uncollected ad valorem taxes are generally personal property accounts for which the statute of limitation has expired or bankruptcy has been filed. A request is made for Council to amend the tax roll only after the City's outside attorneys, Gay, McCall, Isaacks, Gordon & Roberts, P.C. have performed extensive collection efforts.

CONSIDERATION

Amounts are requested for write-off only after they have remained uncollected for a period of at least four years (two years for bankruptcy settlements) and the City's outside attorneys, Gay McCall, Isaacks, Gordon & Roberts, P.C. have performed extensive collection efforts.

Article IX, Section 3 of the City Charter grants the City Council the authority to cancel any uncollected taxes upon the tax rolls.

Amendment of the tax roll is necessary to meet generally accepted accounting principles, avoid overstatement of accounts receivable on the Balance Sheet and avoid risk of a qualified audit opinion from the external auditors.

 Option 1 - Authorize Amendment Agreement No. 3 between the City and its automated red light enforcement vendor (Xerox State and Local Solutions, Inc.). This item is scheduled for formal consideration at the August 21, 2012 Regular Meeting.

COUNCIL GOAL

Safe, Family-Friendly Neighborhoods – By accepting the amendment, the City Council will give the City of Garland the ability to continue with this program providing for an even greater level of traffic safety through the enforcement of red light violations.

Financially Stable Government - By accepting this amendment, the City of Garland will be afforded a credit of \$72,000 applied to the SafeLight Program.

BACKGROUND:

The agreement between the City and its automated red light enforcement vendor (Xerox State and Local Solutions, Inc.) has been updated in order to formalize a number of operational changes that the parties have operated under for some time. The original Agreement was executed on January 30, 2006, Amendment Agreement No. 1 was

executed August 26, 2006 and Amendment Agreement No. 2 was executed May 29, 2009. There are provisions in the existing agreement that are either no longer necessary or that are in need of modification. Also, the agreement needs to be modified to reflect needed changes that were recognized during the most recent internal audit of the SafeLight program, including a credit to the City for \$72,000 in deferred revenue during a period when some of the monitored approaches were off-line. The changes will impose new performance standards on the vendor and will discontinue the City's obligation to pay certain collection costs for services that the City no longer needs. The changes will clarify provisions of the current agreement that relate to decommissioning cameras.

CONSIDERATION:

If approved, the amendment will allow the City to make the necessary operating changes, impose new performance standards, and will include a \$72,000 credit to the program.

AMENDMENT AGREEMENT NUMBER 3 TO AUTOMATED RED LIGHT ENFORCEMENT SERVICE AGREEMENT BY AND BETWEEN XEROX STATE & LOCAL SOLUTIONS, INC. AND THE CITY OF GARLAND, TEXAS

THIS AMENDMENT AGREEMENT NUMBER 3 ("Amendment Number 3") between XEROX State & Local Solutions, Inc., formerly, "ACS State & Local Solutions, Inc.", a New York corporation, with offices at 2828 North Haskell Road, Dallas, Texas 75204 ("Contractor" or "XSLS"), and the City of Garland, Texas, a Texas home-rule municipality ("City"), is made to amend the [Amended and Restated] Automated Red Light Enforcement Service Agreement, effective January 24, 2006 by and between the Contractor and the City (as amended, the "Services Agreement").

WHEREAS, the City has engaged the Contractor to provide certain services to the City under the terms and conditions set forth in the Services Agreement; and

WHEREAS, it is the mutual desire of the parties to enter into this Amendment to modify certain provisions of the Services Agreement relating to the services to be performed by and compensation to be paid to the Contractor.

NOW, THEREFORE, in consideration of the foregoing, and the benefits to accrue to the parties and to the public from this Amendment, the parties agree that the Services Agreement is amended as follows:

I. The parties agree that effective as of September 1, 2012, Amendment Number 1 to the Services Agreement shall no longer be effective, and the original language of the Services Agreement is reinstated except to the extent it is amended by this Amendment Number. 3

II. Section 2 "Work - Scope of Services" of the Services Agreement is hereby amended and the following text shall be added after subparagraph (J) "Public Relations":

"(K) Delinquent Collections. XSLS agrees to perform the following services to assist the City with its delinquent collections and registration hold programs:

(1) The creation and delivery to the City of an electronic file identifying violations eligible for registration hold in a format and pursuant to a schedule mutually agreed to by the parties.

(2) The printing and first class mailing at XSLS' cost of up to three notices in formats and pursuant to a schedule mutually agreed to by the parties.

(3) The creation of an on-line return on investment report in an agreed format that allows the City to track the cost-effectiveness of its registration

hold program. The City agrees to use all reasonable efforts to pursue delinquent collections and registration hold for all eligible records."

III. In reference to Section 4(C) of the Services Agreement, the parties agree that the City shall not be obligated to apply excess Program Revenues generated prior to November 1, 2007 to any cumulative balances due to XSLS for fees incurred by the City under the Services Agreement on or after November 1, 2007. XSLS hereby waives any claim under the Services Agreement to those Program Revenues.

IV. In reference to Section 4(C) of the Services Agreement, XSLS acknowledges that effective November 1, 2007 and running through August 31, 2012, the City retained certain Program Revenues generated on or after November 1, 2007 to pay for City internal program administrative costs. XSLS hereby waives any claim under the Services Agreement to those retained Program Revenues.

V. Effective September 1, 2012, the first sentence of Section 4(C) of the Services Agreement shall be deleted in its entirety and replaced with the following new first, second, and third sentences of Section 4(C) of the Services Agreement:

"XSLS agrees that the City's obligation to pay the monthly base fee shall be limited to those revenues generated by the Program, collected by XSLS, and received by the City less \$8,500.00 per month to be retained by the City to cover a portion of the City's internal program administrative costs ("Program Revenues"). Additionally, XSLS agrees that, when tendering payment to XSLS, the City may designate how those funds are to be applied to indebtedness under the Services Agreement, that is, a portion of the payment may be designated for application to the monthly base fee then due and a portion may be designated to any deficit or balance due as further described in this paragraph. XSLS will allocate the City's payment as so designated."

VI. Section 4 "Compensation" of the Services Agreement is hereby amended and the following subparagraphs (E), (F), and (G) shall be added after subparagraph (D):

"(E) The parties agree that an administrative fee of \$3.75 shall be added to each pay-by-web transaction. Administrative fees shall clear directly into a City designated account, and XSLS shall itemize such administrative fees on a daily cashiering report that the City can access through the program database. As part of its monthly invoice, XSLS shall submit to the City a copy of the monthly bill from XSLS' credit card merchant for reimbursement by the City. The City may, by written notice to XSLS, increase or decrease the administrative fee from time-to-time to make the fee consistent with similar pay-by-web or credit card fees charged by the City."

"(F) In the event that a Unit at a currently operating Installed Approach is not substantially functioning for a period of three or more calendar days within a

calendar month (it being agreed that the days need not be consecutive days), Contractor agrees to prorate the monthly base fee specified in Section 4(B) of this Agreement for that approach for each day in excess of three that the Unit is not substantially functioning. For purposes of this subsection, "not substantially functioning" means failing to accurately detect, measure or record, in the manner described by Chapter 707, Texas Transportation Code and through no fault of the City, its employees, agents, or contractors, fifty percent or more of red light violations by motor vehicles occurring at the approach. By way of example only, if the Unit at an approach is not substantially functioning for one day in excess of the three day allowance in a thirty day month, the prorated monthly fixed fee for the approach would equal 29/30 multiplied by the full monthly fixed fee for the approach (currently \$4950.00) for a payment due for that approach of \$4785.00."

"(G) Contractor agrees that the Units are required to collectively achieve at least an eighty percent Monthly Controllable Issuance Rate. The Monthly Controllable Issuance Rate is determined by the sum of the number of actual violations detected at all approaches (that is, not including non-violation Unit triggers) in the applicable month that result in issued notices of violation divided by the number of Controllable Violations for the month. "Controllable Violations" means the total number of actual violations detected less "Uncontrollable Rejects". Uncontrollable Rejects are those violations for which a notice of violation cannot be issued for one or more of the following reasons:

Plate obstructed DMV no hit Temporary tag Car obstructed Vehicle match failure Glare on plate No plate Direct sun glare Dealer tag Plate damaged Expired - City Weather Multiple Vehicles

If Contractor fails to achieve at least an eighty percent Monthly Controllable Issuance Rate for a given month, Contractor agrees to reduce its monthly invoice by the percentage shortfall on a one-to-one basis. By way of example only, if the Monthly Controllable Issuance Rate achieved in a given month is seventy-five percent, Contractor shall reduce its monthly invoice for such month by five percent; if the Monthly Controllable Issuance Rate achieved in a given month is seventy percent, Contractor shall reduce its monthly invoice for such month by ten percent; if the Monthly Controllable Issuance Rate achieved in a given month is fifty percent; if the Monthly Controllable Issuance Rate achieved in a given month is fifty percent, Contractor shall reduce its monthly invoice for such month by thirty percent, and so on."

VII. The City acknowledges and agrees that at City's request in 2007, XSLS reconfigured the approaches at NB Plano Road @ Buckingham Road and SB Jupiter Road @ Kingsley Road to comply with newly enacted State legislation. As compensation for this work, the City agreed to pay a fee to XSLS in the amount of \$662.76 (inclusive of both intersections) per month beginning in October 2007 and ending in September 2012.

VIII. The City acknowledges and agrees that at City's request in 2009, XSLS relocated three camera systems to new approaches at NB South 1st Street @ Avenue B, SB Broadway Boulevard @ I-30, and NB Shiloh Road @ 190. As compensation for this work, the City agreed to pay XSLS a total fee of \$3,792.64 (inclusive of all three intersections) per month beginning in May 2009 and ending in February 2014. XSLS acknowledges and agrees that, due to circumstances beyond the control of the parties, there was a significant delay following the City's decision to decommission three other cameras prior to the relocation of the three camera systems referenced in this paragraph during which time the City agreed to continue paying the base monthly fee for the three decommissioned cameras. In recognition of certain cost savings that XSLS may have realized during that time, XSLS agrees to waive and not invoice the City for the amount of \$72,133.59 in fees that have been deferred under Section 4(C) of the Services Agreement.

IX. The last sentence of the second paragraph of Section 6(B) of the Services Agreement is amended to read as follows:

"For purposes of this Section 6(B) only, the City and Contractor agree that the implementation cost of an Installed Approach is \$59,700."

X. Section 6 of the Services Agreement is hereby amended and the following subparagraph (D) shall be added after subparagraph (C):

"(D) *Decommissioning and Wind-Down Costs.* If the City determines that it no longer desires to operate a Unit at an Installed Approach, the City may decommission that Unit by providing not less than ninety days written notice to Contractor of the City's intent to decommission that Unit, in which event Contractor shall promptly discontinue operating that Unit. Notwithstanding the decommissioning of a Unit designated by the City, the City agrees to pay any remaining un-amortized installation costs for the Unit being decommissioned including all reasonable costs incurred by Contractor in removing the Unit from its location at the Installed Approach, less the fair market value of any re-usable components including, without limitation, the camera or the detectors."

XI. Section 8 of the Services Agreement is hereby amended by numbering the first paragraph as subparagraph (A) and adding the following subparagraph (B):

"(B) Contractor agrees to obtain a Statement on Standards for Attestation

Engagements No. 16 (Service Organization Control 2 Type II) report from a third party auditing firm on an yearly basis and will, upon request, provide the City with the report."

XII. Section 12 of the Services Agreement is hereby amended by adding the following text after the last sentence:

History and Information Related to Banning Cell Phones in Garland By Rick Williams August 8, 2012

The Garland City Council on several occasions in the last 5 years has chosen not to implement the State-law prohibition of using hand-held cell phones in school zones. Below is information and history related to this issue:

Reasons given by those voting not to ban cell phones:

<u>Many other distractions</u>: One council representative pointed out that cell phones are just one of many distractions that can adversely affect a driver in a school zone, and the other causes are not banned.

Banning in a school zone doesn't address the danger. Specifically:

- 1. The danger of using a cell phone is when someone is using the phone OUTSIDE the zone, misses the school zone signs, and speeds through the zone going 40 mph instead of slowing down to 20 mph.
- 2. So, a cell phone ordinance needs to deal with the cause of this problem which is cellphone use OUTSIDE the school zone which caused speeding through the zone.
- 3. However, the proposed ordinance is to ban cellphones INSIDE school zones, not OUTSIDE, and so the ordinance does not address the problem.

Difficult to enforce: It was argued that it is difficult for police to enforce and if a policeman were writing a cell phone ticket, a speeder might go through zone with impunity.

<u>Effectiveness</u>: Many studies have shown that such bans in are ineffective:

Cell Phone Bans Don't Reduce Crashes, Study Says

ARLINGTON, VA - As more state legislatures across the U.S. enact laws that ban phoning and texting while driving, a new <u>Highway Loss Data Institute study</u> has found no reductions in crashes after handheld phone bans take effect.

Comparing insurance claims for crash damage in four U.S. jurisdictions before and after such bans, the researchers found steady claim rates compared with nearby jurisdictions without such bans. The Highway Loss Data Institute (HLDI) is an affiliate of the Insurance Institute for Highway Safety. HLDI researchers calculated monthly collision claims per 100 insured vehicle years (a vehicle year is one car insured for one year, two insured for six months each, etc.) for vehicles up to three years old during the months immediately before and after hand-held phone use was banned while driving in New York (November 2001), the District of Columbia (July 2004), Connecticut (October 2005), and California (July 2008).

Comparable data were collected for nearby jurisdictions without such bans. This method controlled for possible changes in collision claim rates unrelated to the bans -- changes in the number of miles driven due to the economy, seasonal changes in driving patterns, etc.

Month-to-month fluctuations in rates of collision claims in jurisdictions with bans didn't change from before to after the laws were enacted. Nor did the patterns change in comparison with trends in jurisdictions that didn't have such laws.

"The laws aren't reducing crashes, even though we know that such laws have reduced hand-held phone use, and several studies have established that phoning while driving increases crash risk," said Adrian Lund, president of both the Insurance Institute for Highway Safety and HLDI.

For example, an Insurance Institute for Highway Safety study that relies on driver phone records found a four-fold increase in the risk of injury crashes. A study in Canada found a four-fold increase in the risk of crashes involving property damage. Separate surveys of driver behavior before and after hand-held phone use bans showed reductions in the use of such phones while driving.

The HLDI database doesn't identify drivers using cell phones when their crashes occur. However, reductions in observed phone use following bans were so substantial and estimated effects of phone use on crash risk were so large that reductions in aggregate crashes would be expected.

In New York the HLDI researchers did find a decrease in collision claim frequencies, relative to comparison states, but this decreasing trend began well before the state's ban on hand-held phoning while driving and actually paused briefly when the ban took effect. Trends in the District of Columbia, Connecticut and California didn't change.

"So the new findings don't match what we already know about the risk of phoning and texting while driving," Lund pointed out. "If crash risk increases with phone use and fewer drivers use phones where it's illegal to do so, we would expect to see a decrease in crashes. But we aren't seeing it. Nor do we see collision claim increases before the phone bans took effect. This is surprising, too, given what we know about the growing use of cell phones and the risk of phoning while driving. We're currently gathering data to figure out this mismatch."

HLDI researchers compared the District of Columbia's collision claim frequency trend not only with statewide trends in Virginia and Maryland but also with the trend in the nearby city of Baltimore. Again, the finding is no difference in the pattern of collision claims. Nor were any differences apparent when the researchers applied a time-based regression model to claims data for each of the study and comparison jurisdictions.

Lund pointed to factors that might be eroding the effects of hand-held phone bans on crashes. One is that drivers in jurisdictions with such bans may be switching to hands-free phones because no U.S. state currently bans all drivers from using such phones. In this case, crashes wouldn't go down because the risk is about the same, regardless of whether the phones are hand-held or hands-free. Twenty-one states and the District of Columbia do prohibit beginning drivers from using any type of phone, including hands-free, but such laws are difficult to enforce. This was the finding in North Carolina, where teenage drivers didn't curtail phone use in response to a ban, in part because they didn't think the law was being enforced.

Despite calls for cellphone bans, there's no conclusive data on handheld devices and safe driving

A bill pending in Springfield would ban all drivers in Illinois from using handheld cellphones in Illinois. An ordinance being considered in Evanston would go further and prohibit motorists in that town from talking on cellphones of any kind — including hands-free.

It's a matter of safety, proponents of both measures say.

But two decades of research done in the U.S. and abroad have not yielded conclusive data about the impact cellphones have on driving safety, it appears. Nor is there a consensus that hands-free devices make for safer driving than handheld cellphones.

In theory, the effect of cellphones on driver performance should be relatively easy to determine: Compare crash data against phone records of drivers involved in accidents. But phone records are not easily obtained in the United States, forcing researchers in this country to find less direct ways to analyze the danger of cellphone distraction. The issue is further clouded because auto accidents overall have been decreasing, even as cellphones become more common.

"The expectation would be that as cellphone use has skyrocketed we would see a correlation in the number of accidents, but that hasn't happened," said Jonathan Adkins, spokesman for the Governors Highway Safety Association.

Adkins said the association believes that states should simply enforce their current cellphone laws, if any, and wait for further research to better understand exactly how much of a role cellphone use plays in automobile accidents.

"We know it's distracting, we know it increases the likelihood of a crash," Adkins said. "It just hasn't shown up in data in a lot of cases — in other words, it's hard to prove that a crash was caused because someone was on their cellphone."

State Rep. John D'Amico, D-Chicago, emphasized that traffic safety is behind the handheld ban legislation he sponsored, which passed the House this month and is now being considered by the state Senate. It would make Illinois the 10th state to have such a ban, though several towns in the state already have their own limits. A current state law bans hand-held cellphone use only in construction and school zones and prohibits cellphone use for drivers 18 and younger.

"I want to make sure that people understand that drivers need to be responsible because they're taking other people's lives into their hands when they're driving a car and using a handheld cellphone," D'Amico said.

Proponents of cellphone restrictions — whether total bans or prohibition of handheld phones — can cite some studies to back up their positions.

A 2005 study published in the British Medical Journal looked at crash data for 456 cellphone subscribers in Perth, Australia, who had an auto accident that required medical attention. The study, which essentially confirmed a similar 1997 study conducted in Toronto, concluded that drivers talking on their phones were about four times more likely to be involved in an accident than those who were not on the phone.

Another highly publicized 2006 study from the University of Utah concluded that drivers who talked on cellphones were as impaired as drivers who were intoxicated at the legal bloodalcohol limit of 0.08. The study, however, found that using hands-free devices did little to improve drivers' performances.
